REGULATIONS made by the Minister responsible for Agriculture in exercise of the powers conferred upon him by section 86 of the Belize Agricultural Health Authority Act, Chapter 211 of the Substantive Laws of Belize, Revised Edition 2020, and all other powers thereunto him enabling.

1. These Regulations may be cited as the

BELIZE AGRICULTURAL HEALTH AUTHORITY (SERVICE FEES) REGULATIONS, 2022.

2. -(1) In these Regulations, unless the context otherwise requires-

Interpretation.

"Authority" means the Belize Agricultural Health Authority established under section 3 of the Act:

CAP. 211.

"accredit" or "accredited" means officially recognized by the competent authority to certify, inspect or audit the quality, diagnostic or calibration laboratory, and to verify in the national environ, the compliance of technical conditions and requirements required for the functioning of the entities responsible for control and verifications of sanitary and Phytosanitary measures;

"Biosecurity" means a set of management and physical measures designed to reduce the risk of introduction, establishment and

trioi o

spread of animal diseases and plant pests, infections or infestations to, from and within an animal population or plant system, respectively;

"cargo vessel" means any conveyance carrying commodities from one place to another; "certificate" means an official document which attests to the sanitary or phytosanitary status of any consignment affected by sanitary or phytosanitary regulations; "certification" means the procedure by which official certification bodies or officially recognized certification bodies provide written or equivalent assurance that foods or food control systems confirm with requirements. Certification of food may, as appropriate, be based on a range of inspection activities which may include continuous online inspections, auditing of quality assurance systems, and examination of finished products:

"Clearance" means the release of regulated commodities or products from quarantine after inspection, testing or treatment;

"commodity" means any type of plant, animal, their products and byproducts, or other article being moved for trade or other purpose;

"consignment" means a quantity of plants, plant products, animal and animal products or other regulated commodity being moved from one country or region to another;

"consignment in transit" means a consignment that is not imported into a country but passes through it to another country, subject to official procedures which ensure that it remains enclosed, and is not split up, or combined with other consignments or has its packaging changed;

"construction material" includes cement, steel, plywood, fibre-cement, stone, sand, gravel, ceramic tiles, cement blocks, ceramic bricks, marble stones, granite and any other like material;

"carrier" means any vessel, aircraft, vehicle, cart, container, animal or other thing that can convey plants, plant products, animal, animal products, carcass, biologics, veterinary drugs pests, beneficial organisms, or other commodity from one place to another;

"cruise ship" means a ship carrying fare-paying passengers on a tour and calling on a port in Belize;

"cut flowers and branches" means a class of commodity of fresh parts of plants intended for decorative use and not for, planting;

"designated officer" means a person employed and/or accredited to carry out the functions of the Authority;

"entry" means, in relation to a consignment, movement through any official designated point of entry into the territory of Belize;

"exporter" means anyone who, whether as owner, consignor, consignee, agent, broker or otherwise, is in possession of or in any way entitled to the custody of any plant, plant product, animal, animal product, pest, beneficial organism or other regulated article landed or likely to be landed in any country or region other than Belize;

"floral arrangement" means a regulated commodity which is made of flowers or flora with greens and placed in a proper order or in a correct or suitable sequence or adjustment and includes bouquets;

"greens" means and includes ferns, stems, leaves, grass and branches;

"import" means bringing into Belize by any means whatever;

"importer" means any person who, whether as owner, consignor, consignee, agent, broker or otherwise, is in

possession of, or in control of, in any way entitled to the custody of any plant, plant product, animal, animal product,

"import permit" mean an official Belize Agricultural Health Authority document authorizing the importation of a commodity in accordance with specified sanitary and/or phytosanitary requirement;

"inspection" means official visual examination of plants, plant products, animals, animal products or other regulated articles to determine if pests or diseases are present and/or to determine compliance with sanitary and phytosanitary regulations;

"large yacht" means a vessel measuring fifty (50) feet or more in length and/or ten (10) feet or more in width; 'noncommercial purposes" means the use of imported commodities or products for purposes other than for sale to the general public;

"normal working hours" means the hours between 8:00 a.m. and 5:00 p.m. from Monday to Friday in each week, except on a bank or public holiday;

"point of entry" means any airport, seaport or land border point officially designated for the importation of consignments, and/or entrance of passengers;

"quarantine" means the measure or action by which the Authority may release regulated commodities or products from biosecurity control after inspection and determination of compliance with import requirements or determine the actions required such as: retention, testing, observation, isolation, research, treatment, confiscation, destruction, or return to origin;

"regulated commodity" means any restricted article, animal, animal products, litter, biological or animal feed, veterinary

drugs, veterinary biologicals, veterinary pesticides, food, commodity, storage place, packaging, carrier, container, soil and any organism, object or material capable of resulting in the entry, harbouring or spreading of pests or diseases;

"sanitary and phytosanitary measure" include all relevant laws, decrees, regulations, requirements and procedures including, inter alia, end product criteria, processes and production methods; testing, inspection, certification and approval procedures; quarantine treatments including relevant requirements associated with the transport of animals or plants, or with the materials necessary for their survival during transport; provisions on relevant statistical methods, sampling procedures and methods of risk assessment; and packaging and labelling requirements directly related to food safety;

"small aircraft" means an aircraft having a maximum takeoff weight less than 12,500 pounds (5,760 kilograms), that is designed to carry a small number of passengers or a small amount of goods;

"small yacht" means a vessel measuring less than fifty (50) feet in length and/or less than ten (10) feet in width;

"station" means the place where a designated officer is assigned to remain or work

"wood packaging material" means wood, dunnage or wood products, excluding paper products, used in supporting, protecting or carting a commodity.

(2) The words and expressions used in these Regulations shall have the meaning assigned to them in the Belize Agricultural Health Authority Act unless such words and expressions are defined in sub-regulation (1).

CAP. 211.

Export Certification.

- 3. -(1) All exports which require certification shall be inspected by a designated officer prior to the issuance of a Sanitary, International Veterinary Certificate, Phytosanitary Certificate or Phytosanitary Certificate for Re-Export."
- (2) Every exporter of a commercial commodity or his authorized agent shall ensure that all necessary information including sanitary or phytosanitary requirements of the importing country, are presented to the designated officer not less than seventy-two (72) hours prior to the inspection date.
 - (3) The Authority shall only certify commodities that-
 - (a) are fully compliant with the certification process of the authority; and
 - (b) meet the sanitary and/or the phytosanitary requirement of the importing country.
- (4) Where a certification process entails sampling, testing or treatment every exporter or authorized agent shall-
 - (a) provide free samples to the Authority;
 - (b) provide free access to the Authority to collect the samples and conduct the certification process;
 and
 - (c) pay the fees as applicable in Schedule I, II and III-
 - (i) for sampling;
 - (ii) for testing;
 - (iii) for treatment; and

(iv)associated with inspection and issuance of the specific export certificate or Certificate of Treatment, where applicable.

- (5) Every exporter of a consignment, or his authorized
- agents, shall pay the authority the fees set out in Schedules I, II and III for the issuance of a Sanitary, International Veterinary

Certificate, Phytosanitary Certificate or Phytosanitary Certificate for Re- Export.

(6) All fees payable under this Regulation shall be borne by the exporter and paid to the designated officer upon completion of the inspection or to the Authority at any of their offices throughout the country of Belize.

(7) Where there are no provisions for the issuance of Sanitary Certificates this Regulation shall apply and shall

- be read and construed together with the Belize Agricultural Health Authority (Food Safety) Regulations 2001 (S.1. 25 of 2001) and the Belize Agricultural Health Authority (Fish and Fisheries Products Inspection) Regulations, 2001 (S.I. 173 of 2001).
- (8) A mileage fee of one dollar and seventy-five cents (BZ \$1.75) per miles shall be paid to the Authority for field inspections in respect of the issuance of the certificates referred to in this Regulation.
- (9) Fees for inspection at packing and processing facilities shall be as prescribed in Schedule I, II, and III.
- (10) All exporters are required to register annually with the Authority and pay the prescribed fee set out in Schedules I, II, and III.
- (11) All fees payable under this Regulation shall be paid immediately to the designated Officer or to the Authority at any of their offices throughout the country of Belize upon

Boarding etc of vessels.

4.—(1) Every shipping agent, owner of a vessel, and any owner of a private marina or his authorized agent shall inform a Quarantine Inspector of scheduled arrivals of vessels coming from international ports within twenty-four hours prior to the scheduled arrival of such vessels.

- (2) No permission to land shall be granted unless a ship inspection has been conducted by a designated officer and his findings indicate full compliance with the Sanitary and Phytosanitary regulations of Belize.
- (3) Prior to the boarding of sea vessels every owner, captain of a vessel or his authorized agent shall present to the Quarantine Inspector the following documents—
 - (a) cargo manifest;
 - (b) packing list;
 - (c) container list;
 - (d) passenger list;
 - (e) stores list; and

- (f) the NIL list prescribed in Schedule IV; and
- (g) any other document deemed necessary.
- (4) Every owner of a vessel, or his authorized agent, shall pay to the Authority, the fees for boarding and quarantine inspection of the vessel as prescribed in Schedule V.
- (5) The inspection fee shall run form the time the designated officer leaves his station until the time he returns

to his station and any additional fee incurred shall be borne by the Captain or Owner of the vessel.

- (6) The owner or captain of a vessel shall make payments directly to the designated officer conducting the quarantine inspection.
- 5. -(1) Every airline representative, owner of an aircraft, and private dispatching agent shall inform the designated officer of scheduled arrivals at the international airport within twenty-four hours prior to the scheduled arrival.

Boarding etc. of aircraft.

- (2) Prior to boarding any aircraft, any airline representative, owner of the aircraft or his authorized agent shall present the following documents to the Quarantine Inspector—
 - (a) cargo manifest;
 - (b) packing list;
 - (c) passenger list; and
 - (d) any other documents deemed necessary.
- (3) Every owner of an aircraft or his authorized agent, or airline representative shall pay the fees stipulated in Schedule V to the Authority for boarding and quarantine inspection of such aircraft.".

Schedule V.

- (4) The owner of the aircraft or his authorized agent, or airline representative shall pay the certified transportation expenses of the designated officer.
- (5) The inspection fees referred to in Schedule V shall run from the time the designated officer leaves his station until the time he returns to his station.

Schedule V.

(6) Where an inspection has to be conducted outside of normal working hours, the owner of the aircraft or his authorized agent; or airline representative shall pay to the Authority the fees associated with the inspection of the aircraft including an overtime rate of BZ \$45.00 per hour per designated officer on duty.

(7) The owner of an aircraft or pilot shall pay the designated officer conducting the quarantine inspection directly

6. -(1) Any person desiring to import any regulated Import permit. commodity into Belize shall apply for an import permit for such commodity or product.

> (2) No person shall import any commodity unless such person possesses a valid import permit from the Belize Agricultural health Authority.

> (3) Any person desiring to import any commodity into Belize shall pay the Authority an import permit application fee as prescribed in Schedules I, II and III.

> (4) Fees associated with the registration of veterinary drugs, veterinary biologics, veterinary pesticides and animal fee shall be as prescribed in Schedules I.

(5) Fees associated with post entry quarantine shall be as prescribed in Schedules I, II and III; any additional fees incurred shall be paid to the Authority by the owner or his authorized agent upon receipt of an official bill.

7.- (1) The Authority shall conduct an import risk analysis

- (b) a commodity originates from a country or a region not previously approved;
- a commodity originates, comes from or passes through a county or region whose health status changes or is not known to the Authority;
- (d) there is new information on a particular pest or disease;
- (e) the validity of the certification period for a facility or regulated product has expired; or
- (f) based on the availability of new scientific information, the Authority deems it necessary.
- (2) An importer shall provide supporting evidence on an export commodity to the Authority for the determination on the level of risk to Belize.
- (3) Every import risk analysis conducted under regulation 7(1) shall incur a fee of one thousand dollars (BZ \$1,000.00) payable to the Authority upon application.
- (4) Where an import risk analysis requires inspection in a foreign country in accordance with regulations prescribed therefor, the interested parties shall bear all expenses associated with the inspection as prescribed in Schedule VI.

Schedule VI.

8.-(1) Every imported commodity shall be inspected by a designated officer to determine if a landing permit shall be issued for such commodity.

Inspection of imported commodities.

(2) The cost of quarantine clearance and any sanitary or phytosanitary measure required subsequent to the inspection shall be borne by the importer.

(3) The importer of a commodity referred to in subregulation (1) shall pay the Authority the fees prescribed in Schedule V. Schedule V for quarantine inspection.

- (4) Where a commodity is non-compliant with import conditions the Authority shall confiscate, destroy or cause them to be returned to the country of origin at the owner's expense.
- (5) Governmental bodies, qualifying governmental organizations or statutory bodies importing a commodity for non-commercial purposes may apply to the Managing Director for a waiver of fees prescribed in these regulations.

In transit commodities.

- 9.-(1) Every commodity which is in transit through Belize shall require an import permit.
- (2) The owner of such commodity or his authorized agent, shall pay to the Authority the fees for quarantine inspection prescribed in Schedule V. Schedule V.
 - (3) The fees shall be paid promptly to the Authority before the inspection.
 - (4) Every owner of a commodity referred to in subregulation (1) or his authorized agent, shall pay any other expenses of the designated officer incurred in carrying out his duties under this Regulation.
 - (5) The expression "other expenses' referred to in subregulation (4) includes transportation, overtime, subsistence and accommodation expense incurred by the designated officer during the process of traveling from the point of entry to the point of departure in Belize, including the commercial free zones as well as costs associated to emergency response and risk mitigation that may occur during transit of the commodity.

(5) For the purposes of this Regulation, "page" mean one side of a letter size (8.5 inches X 11 inches) typewritte sheet of single spaced character with margins of one inch (all sides.

17. The Authority shall issue an official receipt for at Receipt. payments made under these Regulations.

18. The Veterinary Diagnostic Laboratory, the Central Investigation Laboratory, and the Plant Health Laboratory, are hereby designated as the official diagnostic laboratories for the purposes of these Regulations.

Designated diagnostic laboratory.

19.—(1) Any passenger who makes a false verbal declaration to a Customs Officer or Quarantine Inspector, pertaining to the importation of plants, animal and their products and byproducts. In their personal luggage, shall pay an administrative fine of two hundred dollars (BZ\$200.00) payable to the Authority.

Administrative fines and penalties.

- (2) Where an importer of a regulated commodity fails to produce a valid import permit the Authority may, upon review, approve entry after inspection and testing after payment of the stipulated inspection fee, and the following administrative penalty-
 - (a) one thousand dollars (BZ 1,000.00) per consignment; or
 - (b) three hundred dollars (BZ 300.00) per each domestic dog or cat.
- (3) Where an importer of a regulated commodity produces a valid import permit but fails to produce supporting documents for such regulated commodity the Authority shall immediately detain the commodity and determine whether to allow or refuse entry based on an assessment of risk.
- (4) Where entry is allowed under sub-regulation (4), the importer shall pay all fees that may be incurred and the following administrative penalty—
 - (a) one thousand dollars (BZ 1,000.00) per consignment; or
 - (b) three hundred dollars (BZ 300.00) per each domestic dog or cat.

(5) Notwithstanding sub-regulation (2) and (3), the Authority shall determine the process to execute in order that the commodity be refused entry and sent back to country of origin, confiscated and treated or confiscated and destroyed at the expense of the importer or his agent.

Offences and penalty.

- 20.-(1)A person commits and offence if they-
 - (a) are found in illegal possession of any plant, plant product, plant by-product, animal, animal product, animal by-product carcass, feed, liner, dung, biologicals or similar commodity;
 - (b) break a quarantine seal;
 - (c) fail to inform a designated officer of scheduled arrivals of any carrier coming from either an International port or airport within twenty-four hours prior to the scheduled arrival;
 - (d) fail to allow the boarding of any carrier for inspection to be conducted by a designated officer of the Authority;
 - (e) boards any carrier without the presence of a designated officer;
 - (f) imports into Belize any commodity or product to which Parts VI and X of the Act do not apply, otherwise than under an import permit granted by the Authority;
 - (g) presents a false document for import or export purposes or tampers with a BAHA stamp or document (Certificates, Permits, Receipts etc.); or

- (h) contravenes or fails to comply with any of the provisions of any import permit referred to in sub-regulation (f).
- (2) Every person who commits an offence under subregulation (1) shall be liable on summary conviction to a fine not less than two thousand dollars, but not exceeding ten thousand dollars, or to a period of imprisonment not exceeding two (2) years, or to both such fine and period of imprisonment.
- 21. Failure to declare any regulated commodity to a designated officer at a point of entry shall result in the confiscation of the commodity and the importer of the commodity shall be subject to a penalty as follows—

Penalty for failure to declare regulated commodities, etc...

- (a) where the commodity is of commercial quantity-
 - (i) two thousand dollars (BZ\$ 2,000.00) for a first offense;
 - (ii) three thousand dollars (BZ\$ 3,000.00) for a second offense; or
 - (iii) five thousand dollars (BZ\$ 5,000.00) for a third offence;
- (b) where the commodity is of non-commercial quantity-
 - (i) two hundred and fifty dollars (BZ\$ 250.00) for a first offense; or
 - (ii) five hundred (BZ\$ 500.00) for a second offense.
- 22. The Belize Agricultural Health Authority (Service Fees) Regulations, 2004 (S.I No. 182 of 2004) are repealed.

 - (a) airfare and other certified travel costs (taxi to airport, airport taxes, visa, etc.) which may be incurred and are associated with the inspection. Tickets shall be sent to the Authority at least three (3) days prior to the intended departure of the designated officer(s);
 - (b) all expenses within reasonable limits in respect of boarding and lodging are to be met;
 - (c) an honorarium of two hundred dollars US (\$200.00) per day per officer;
 - (d) the honorarium shall be paid directly to the designated officers upon arrival at the country requesting the inspection.
- 2. A minimum administrative fee of one thousand dollars (US \$1000.00) shall be paid directly to the Belize Agricultural Health Authority not less than ten (10) working days prior to the intended departure from Belize. An inspection which may result in a length of stay that exceeds a maximum of three (3) working days shall result in an additional administrative fee of one hundred dollars (US \$100.00) per day.
